

2024-25 Canadian Certified Green Representative (CCGR) Certification Participation Contest

Official Rules and Regulations

To Enter: Any REALTOR® member of CREA who earns the Canadian Certified Green Representative (CCGR) Certification online (completes all four eLearning modules and scores above 70% on the final assessment) between 12:01 a.m. Eastern Time (ET), November 20, 2024 and 3:59 p.m. ET, February 28, 2025 (the “Contest Period”) (“Participants”) will be entered for a chance to win one of the prizes set out below. A maximum of one completed Certification and one entry per Participant is allowed. Entries become the property of The Canadian Real Estate Association (“CREA”) and will not be returned.

Prizes: Participants are eligible for a chance to win one of four (4) VISA® gift cards each valued at \$250.00.

The Prizes must be accepted as awarded and are not transferable. A maximum of one prize per Participant will be awarded. CREA reserves the right, in its sole discretion, to substitute a Prize or a component thereof with a prize of equal or greater value.

Drawing: The draw for all Prizes will take place on March 7, 2025, at 1:00 p.m. ET at the offices of CREA located at 200 Catherine St., Ottawa, Ontario. One (1) potential winner and one (1) backup winner for each of the Prizes available will be drawn at random from among all eligible entries received during the Contest Period.

Eligibility: To be eligible to win any Prize, an entrant must: a) be a Canadian resident and a REALTOR® member of CREA; b) have reached the age of majority in the province or territory in which they reside as of 12:01 a.m. ET on November 20, 2024; c) not be an employee, representative or agent of CREA, nor be someone domiciled with any such person, and d) have completed the Canadian Certified Green Representative (CCGR) Certification as indicated above. Contest is void where prohibited or restricted by law. The Contest is subject to all applicable federal, provincial, and local laws and regulations.

Odds: The odds of winning the Prizes depend on the total number of eligible entries received throughout the Contest Period.

Use of Information: By opting to complete the CCGR Certification, an entrant agrees to be entered into the Contest. If selected as a potential winner for the Contest, it will be necessary for CREA to verify that a potential winner fulfills the eligibility criteria for the Contest. No permanent records of any such personal information will be retained by such parties, except for the administration of this Contest.

Winner Notification/Prize Awards: All potential winners will each be notified via e-mail by a representative of CREA on or before 5:00 p.m. ET, March 28, 2025. In order to win a prize, a selected entrant must correctly answer, unaided, a time-limited, arithmetical, skill-testing question within seven (7) days from the time the prize notification is marked as having been sent by e-mail. The skill-testing question will be included electronically in the prize notification e-mail. The Prize will be forfeited and available to be awarded to the alternate winner following the procedures set forth above if: (a) the prize notification is returned as non-deliverable; (b) if the answer to the skill testing question is not returned within seven (7) days from the time the prize notification e-mail is marked as having been sent; or (c) if the skill-testing question is incorrectly answered. In the event the prize notification e-mail is returned as non-deliverable from the alternate winner, the alternate winner does not return the required documentation within seven (7) days, and/or the skill-testing question has been incorrectly answered by the alternate winner, the Prize will be forfeited and not awarded to any further alternates.
